



## LIMITED LIFETIME WARRANTY

### COVERAGE

Barren County Metal extends this warranty to panels, effective from the date of shipment and sold as a warranted or Number One MAC Rib panel as indicated on the customer's original invoice. It applies only to goods used on wood frame buildings and on architectural, commercial, pre-engineered or residential metal buildings, which are installed in the United States, Canada, and Mexico. This warranty shall extend to the purchaser of the material and is non-assignable and/or non-transferable. Should the Purchaser become insolvent, bankrupt, make an assignment for the benefits of its creditors, or for any reason discontinue its normal or regular business practices, this warranty shall forthwith become null and void and of no legal effect. The purchaser must present the original sales receipt for warranty consideration.

### TERMS

Although it is recognized by Barren County Metal that most paint systems will fade and change in appearance to some degree over a period of time in outdoor installations, and that such changes may not be uniform between surfaces not equally exposed, Barren County Metal warrants that the goods covered by this warranty will resist natural weathering to the extent that they will conform to the performance standards listed below during a period of the lifetime of the roof for film integrity and a period of 30 years after shipment for both chalking and color change, provided that all conditions of this warranty are first met. Provisions (1) through (3) below apply to buildings installed north of the 15° parallel of latitude in the northern hemisphere. Only provision (1) applies to buildings south of this latitude.

1. For the Lifetime of the roof, the paint system will not peel, flake or otherwise lose adhesion to an extent that is apparent on ordinary outdoor visual observation. NOTE: Slight cracking may occur on roll-formed edges or break bends at the time of forming, and is considered as standard—such cracking shall not constitute a basis for complaint under this limited warranty; and
2. For thirty (30) years, vertical installations will not change color more than 5 NBS (Hunter) units, and non-vertical installations will not change more than 7 NBS (Hunter) units following field installation. Color measurements are to be made per ASTM D 2244 and only on clean surfaces after removing surface deposits and chalk per ASTM D 3964; and
3. For thirty (30) years, vertical installations will not chalk more than a number 8 rating, and non-vertical installations will not chalk more than a number 6 rating, when measured per ASTM D-4214, Method A.

### EXCEPTIONS

This is an anti-weathering limited warranty and does not apply to other causes of degradation, including:

- A paint system which has suffered scratching or abrasion or impact by a hard object; has been abused, altered, modified, used in a manner not originally intended or stored contrary to instructions of Barren County Metal, or in accordance with good industry practice; is damaged due to moisture entrapment in bundles during transit or storage; is stored or installed in a way which allows standing water on the coating or in any chemically aggressive environment containing fumes, ash, cement dust, carbon black, salts, or other chemicals, whether naturally occurring or caused by man; is stored or installed in an environment that includes a high degree of humidity, sand, dirt, or grease, whether naturally occurring or caused by man; is stored or installed in a way which allows contact with animals and/or animal waste or its decomposition products; is stored or installed in an area, or in such a way, that damage can occur due to poor air circulation; is stored or installed in areas subject to fallout from copper, lead, nickel, or silver mining or refining operations; has suffered any damage caused by acts of God, radiation, falling objects, explosion, fire, riots, civil commotions, acts of war or other external forces;
- A paint system which suffers from improper forming, fabrication, or embossing; cut edge exposure; corrosion of the substrate; or the development of any other condition between the coating and the substrate which causes the coating to degrade or delaminate, including any failure or deficiency in the cleaning process or pretreatment;
- A paint system which is installed within 1000 meters of a salt water or other marine environment.
- This warranty will not extend to or cover damages to the material due to improper shipping, handling, installation, storing, erecting of the panels on the job site and/or any act of negligence of the customer or any third party after the panels leave the possession of Barren County Metal. Claims arising from the following conditions will also not be warranted: a) Steel shavings from sawing sparks that come into contact with the paint surface. b) Damage to the paint surface due to the use of an abrasive saw blade. c) Panels used on or near animal confinement. d) Damage due to the use of wet, green, or treated lumber. e) Use of fasteners not recommended by Barren County Metal, which may be deemed inferior.

### REMEDY

If any of the product fails to perform as warranted, the company will repaint or replace the defective panels at its sole discretion, and Barren County Metal shall bear no liability, except to the options listed above. If Barren County Metal chooses to replace the defective material, the liability is expressly limited to the purchase price of the defective material, and labor costs will not be given due consideration. Barren County Metal will not be held responsible for any losses, damages, or expenses caused by or resulting from the use of defective material. Barren County Metal reserves the right to terminate or modify this warranty except with respect to orders already accepted.
